SP reported that the swing and chains had been removed until a replacement seat was purchased.

SP reported that tomatoes had been thrown at all of the equipment, covering many surfaces with squashed remains.

(v) Buckinghamshire Council

Cllr Waite reported:

- that recruitment for the Proud of Bucks judging panel was underway.
- That there was to be a reduction in the number of actively used Council buildings.
- That there was to be a review of local parking fees and enforcement. SP noted that PCSO Fahy had asked for evidence of people contravening the rules.
- An update on roadworks and permits, and advised Cllrs to use the One Network portal to view current and upcoming roadworks and permits for the following 12 months. Also noting a 44% increase in permits granted since 2019. As well as Bucks Council, there are 63 other agencies with licence to undertake roadworks in the area.
- There had been a meeting with HS2 to look at impact on the local community of last-minute closures with no warning, or no work undertaken during closures. HS2 will review and provide feedback. TW asked for clarification about why there were closures, but no work undertaken. Cllr Waite responded that different departments were responsible for different elements, so there were occasions when a road is closed, but the team due to undertake the actual works are moved to a different site at the last minute.
- That bridge components are to be brought along the A41 during the night.
- That a temporary haul road would be constructed alongside the A41
- That the A41 will be closed for three days from 30th June 2023.
- That there was a meeting the following week to discuss the land at Lower Green.
